Each RSU represents the contingent right to receive one share of the Issuer's Common Stock.
- The option vests 25% on the first year anniversary of the vesting start date of September 16, 2020 and the remaining 75% vests in 36 substantially equal monthly installments thereafter, subject in each case to the Reporting Person's continued employment or service with the Issuer through the applicable vesting date.
